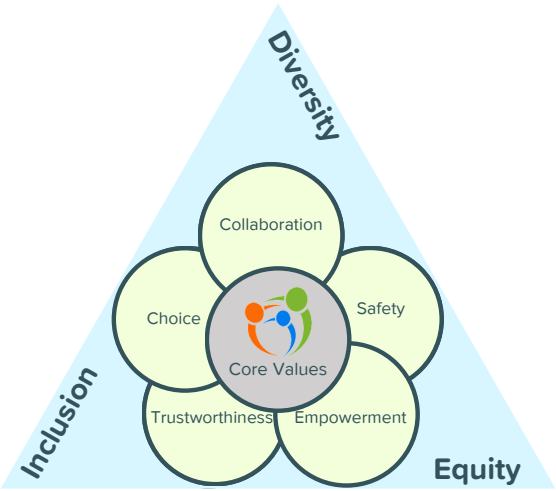


Employee Support Services is designed to empower employees by offering confidential support when facing life's challenges, fostering individual growth and resilience.

Rather, it is an act of strength and courage, motivated by a desire to live a rich and meaningful life with as much happiness as possible.

Employees will be provided short-term therapy for up to 12 sessions per household per contract year.

Free services and supports include Domestic Violence Victim Advocacy, Hispanic Bilingual Family, and LGBTQ+ Services for employees and qualifying members.



Healing centered services, promote resiliency for those who have experienced any of the wide array of life challenges- including but not limited to:

- Couple/relational conflicts
- Challenges in parent-child relationships
- Adolescent adjustment issues
- Adjustment following divorce or death
- Abuse of alcohol or drugs
- Communication breakdown
- Stress, depression, self-doubt, and relationship difficulties
- Concerns regarding aging parents
- Work related stress or challenges
